Hi Chris:

Thank you for your email of this morning: I will try again to contact Senator Gillibrand's office.

Today I actually spoke to Brian Pearce for 30 minutes. He told me that he has updated the relevant databases with the border patrol and homeland security, so that, while the records still indicate that you had been arrested in Thailand, the records also indicate that the legal proceedings have been concluded and that there is no ongoing prosecution (I am aware that such a representation of your status if the Thai system is not consistent with what you told me in your email, but that is what Brian has told the US federal databases).

Brian also told me that the reason there is still an "open file" is because you provided the computer files to the FBI and, believe it or not, the FBI has not completed its review of these files. According to Brian, once that review is completed, the status of the files will change, and the federal databases will reflect that change.

He promised to give me a call when this has been accomplished, which he expects to get done within the next month.
