This contradicts Brian Pearce's February 5, 2015 internal DOJ email "He (Hobbs) was arrested by Thai authorities and investigated by FBI-LA" and "The FBI has a parallel investigation". The RTP did not have a parallel investigation until after December 12, 2013 at which time they were given the FBI investigation files and evidence

This contradicts Randall Devine's April 11, 2014 statement in FBI files "On 04/04/2014, (RTP) arrest warrant for HOBBS based on statements of a child victim obtained June 2013". DHI reports informing RTP on December 12, 2013 of the crimes allowing RTP to start an investigation by providing DHI/FBI testimony and evidence
